# II SPECIFIC PART OF THE EUROPEAN TECHNICAL ASSESSMENT

# 1 Technical description of product and intended use

# **Technical description of the product**

The ARVEX CV is a bonded anchor (injection type) for concrete consisting of a cartridge with Arvex injection mortar and a steel element. The steel element consists of a commercial threaded rod with washer and hexagon nut in the range of M8 to M24 or a reinforcing bar in the range of diameter 8 to 25mm.

The product specification is given in annex A.

The steel element is placed into a drilled hole filled with injection mortar and is anchored via the bond between metal part, injection mortar and concrete.

The characteristic material values, dimensions and tolerances of the anchors not indicated in Annexes shall correspond to the respective values laid down in the technical documentation<sup>1</sup> of this European Technical Assessment.

# 2 Specification of the intended use in accordance with the applicable European Assessment Document (hereinafter EAD)

The performances given in Section 3 are only valid if the anchor is used in compliance with the specifications and conditions given in Annex B.

The provisions made in this European Technical Assessment are based on an assumed intended working life of the anchor of 50 years.

The indications given on the working life cannot be interpreted as a guarantee given by the producer or Assessment Body, but are to be regarded only as a means for choosing the right products in relation to the expected economically reasonable working life of the works.
